WHEREAS, on August 23, 2022, this Board duly adopted Resolution 2022-528 a Resolution Awarding A Contract For Providing In-School Youth Program Services for the Cumberland County Department of Workforce Development, RFP #22-25 Resubmission; and

WHEREAS, the Director of Purchasing has advised that it is necessary to exercise the first option to renew the contract for an additional one (1) year term through to June 30, 2024.


