

PUBLIC NOTICE
CHANGE ORDERS EXCEEDING 20%

The Board of County Commissioners of the County of Cumberland has approved the following change order(s) on July 25, 2023 which increased the original contract amount in excess of twenty percent (20%).

Change Order # 1 to the Bid for Supplying and Delivering Office Furniture and Electronics Equipment for the County of Cumberland and the Cumberland County Cooperative Contract Purchasing System Identifier # 181-CCCCPS.; Bid #21-55; awarded to W. B. Mason Company, Inc.; approved December 21, 2021; this change order increased the original contract amount of \$72,400.00 by \$98,834.82, or approximately 136.52% for a new contract sum of \$171,234.82. Change Order required to increase the maximum contract amount for a large furniture order by the Division of Social Services, Vineland, New Jersey.

Change Order # 1 to the Proposal for Providing Drug and Alcohol Treatment Services for the Cumberland County Alcohol and Drug Abuse Services Office; RFP #22-59; awarded to New Hope Integrated Behavioral Health Care; approved December 20, 2022; this change order increased the original contract amount of \$7,500.00 by \$5,388.00, or approximately 71.84% for a new contract sum of \$12,888.00. Change Order is required to re-allocate grant funding for better utilization in meeting the needs of the community. Agency requested to move money from one contract to the other because there has not been a need for Short Term Residential money and there's a small balance of \$1,601.74 left in Withdrawal Management. Request was sent to DMHAS and was approved by them.

Change Order # 1 to the Proposal for Providing Various Social Services for the Homeless for the County of Cumberland, Cumberland County Department of Human Services; RFP 22-63; awarded to Rural Development; approved December 20, 2022; this change order increased the original contract amount of \$500,000.00 by \$100,000.00, or approximately 20.00% for a new contract sum of \$600,000.00. Change Order is required to allocate additional funds to provide additional emergency shelter. Emergency Shelter is seeking more funding to continue to serve clients until the end of the year. Spending activity shows a need for additional funding as we are only paid up until the end of April and have spent almost half of the current awarded amount of \$500,000.

Change Order # 3 to the Professional Service Contract for Engineering Service Support for the P25 700MHz Digital Trunked Radio System; Pre-Qualified per RFQ #19-50; As Needed General Architect and Engineering Services (V-COMM, LLC) (\$350,000.00 Estimated); awarded to V-COMM, LLC; approved August 25, 2020; this change order increased the original contract amount of \$350,000.00 by \$116,960.00, or approximately 33.42% for a new contract sum of 774,880.00 (which had been increased by a previous change order by \$307,920.00) or approximately 87.98% (where the sum of all change orders result in an increase of 121.40%). This Change Order is required in order for V-COMM to perform consulting services associated with the final sites for the 700MHz system, which have been delayed and/or reconfigured due to unforeseen siting and construction issues.
