The Board of County Commissioners of the County of Cumberland has approved the following change order(s) on August 22, 2023 which increased the original contract amount in excess of twenty percent (20%).

Change Order # 1 to the Competitive Contracting Request for Proposal For Providing Various Social Services For The Cumberland County Youth Services Advisory Council; RFP # 20-62 (Sex Offender Services) (2nd Renewal); awarded to Center for Family Services Inc.; approved December 15, 2020; this change order increased the original contract amount of \$30,000.00 by \$15,000.00, or approximately 50.00% for a new contract sum of \$45,000.00. Change Order required to allocate funds to provide a diversionary program for sexting intervention program services.

Change Order # 1 to the Competitive Contracting Request for Proposal for Community Support Services; Older Americans Act Services for the Elderly and Disabled for the 2022-2024 Area Plan Contract; RFP 21-50 (Adult Protective Services) (1st Renewal); awarded to Resources for Independent Living, Inc.; approved November 22, 2022; this change order increased the original contract amount of \$129,432.00 by \$51,373.00, or approximately 39.70% for a new contract sum of \$180,805.00. Change Order required to allocate mid-year funds to provide additional Adult Protective Services.

Change Order # 1 to the Competitive Contracting Request for Proposal for Community Support Services; Older Americans Act Services for the Elderly and Disabled for the 2022-2024 Area Plan Contract; RFP 21-50 (Certified Home Health Aide) (1st Renewal); awarded to Bayada Home Health Care, Inc.; approved November 22, 2022; this change order increased the original contract amount of \$190,528.00 by \$63,426.00, or approximately 33.29% for a new contract sum of \$253,954.00. Change Order required to allocate mid-year funds to provide additional home care services.

Change Order # 1 to the Competitive Contracting Request for Proposal for Community Support Services; Older Americans Act Services for the Elderly and Disabled for the 2022-2024 Area Plan Contract; RFP 21-50 (Health Promotion/Physical Education) (1st Renewal); awarded to PRAC of Southern NJ; approved November 22, 2022; this change order increased the original contract amount of \$11,000.00 by \$2,679.00, or approximately 24.36% for a new contract sum of \$13,679.00. Change Order required to allocate mid-year funds to provide additional Health Promotion/Physical Education.

Change Order # 1 to the Competitive Contracting Request for Proposal for Community Support Services; Older Americans Act Services for the Elderly and Disabled for the 2022-2024 Area Plan Contract; RFP 21-50 Resubmission II (Nutritional Support Services) (1st Renewal); awarded to Nanticoke Lenni-Lenape Indians of NJ Inc.; approved November 22, 2022; this change order increased the original contract amount of \$10,000.00 by \$10,000.00, or approximately 100.00% for a new contract sum of \$20,000.00. Change Order required to allocate mid-year funds to provide additional funding necessary through end of year for luncheon program due to increase cost of food and for needed kitchen equipment..
