**CHANGE ORDERS EXCEEDING 20%**

The Board of County Commissioners of the County of Cumberland has approved the following change order(s) on December 19, 2023 which increased the original contract amount in excess of twenty percent (20%).

Change Order # 1 to the RFP for Contract For Providing Various Social Services For The Cumberland County Youth Services Advisory Council; Bid #20-62; awarded to Acenda, Inc., 42 South Delsea Drive, Glassboro, NJ 08028 (In-Home Counseling Disposition Category); approved December 15, 2020; this change order increased the original contract amount of \$35,557.00 by \$11,000.00, or approximately 30.94% for a new contract sum of \$46,557.00. Change Order Required to add funds for increased referrals for this program.

Change Order # 1 to the RFP for Contract For Providing Various Social Services For The Cumberland County Youth Services Advisory Council; Bid #20-62; awarded to United Advocacy Group, PO Box 9, Bridgeton, NJ 08302 (Youth Mentoring Program Diversion Category); approved December 15, 2020; this change order increased the original contract amount of \$25,000.00 by \$7,000.00, or approximately 28.00% for a new contract sum of \$32,000.00. Change Order Required to add funds for increased referrals for this program.

Change Order # 1 to the RFP for Professional Service Contract for Construction Service Support for the Replacement of Mayor Aitken Bridge 0600-030, C.R. 697 across Sunset Raceway. Pre-Qualified per RFQ # 18-62; As Needed General Architect and Engineering Services awarded by Res 2018-691, November 27, 2018; awarded to Adams Rehmann & Heggan Associates, 215 Bellevue Avenue, PO Box 579, Hammonton, NJ 08037; approved December 18, 2018; this change order increased the original contract amount of \$56,650.00 by \$30,100.00, or approximately 53.13% for a new contract sum of \$86,750.00. Change Order Required to authorize additional work for construction engineering, permitting and project closeout for the Replacement of Bridge No. 0600-030 (Mayor Aitken Drive over Sunset Lake Raceway).

Change Order # 1 to the RFP for Competitive Contracting Request for Proposal for Providing Various Medical Laboratory Testing Services for the County of Cumberland, RFP #22-01; awarded to Laboratory Corporation of America Holdings (LabCorp), 69 First Avenue, Raritan, NJ 08869; approved January 25, 2022; this change order increased the original contract amount of \$125,164.58 by \$166,000.00, or approximately 75.40% for a new contract sum of \$291,164.58. Change Order Required to add additional funds to cover the cost of continuing excessive on-going Covid-19 Testing.

Change Order # 1 to the RFP for Professional Service Contract to Conduct a Preliminary Assessment for Mid-County Park (Block 3, Lots 8 & 53), to Construct a 5.2 mile Permanent Trail System, RFP# 23-24; awarded to T&M Associates, 11 Tindall Road, Middletown, NJ 07748; approved August 22, 2023; this change order increased the original contract amount of \$5,500.00 by \$6,075.00, or approximately 110.45% for a new contract sum of \$11,575.00. Change Order Required to prepare and implement a site-specific health and safety plan (HASp), collect (11) soil samples with lab analysis using HAP Technical Guidance, and prepare an NJDEP Technical Requirements for Site Remediation/Green Acres Program.
