This project will include reconstruction of the bleacher system and surrounding walkways to allow persons with disabilities access to all events held at the Fairgrounds.

All bids must be made on standard proposal forms included with the contract documents in the manner designated therein. In accordance with U.S. 2 CFR 200.321 Minority and female-owned companies are urged to participate in this opportunity.

Bidders are required to comply with the subcontractor identification requirements of Local Public Contract Law (40A:11-16).

The contractor will be required to pay the appropriate prevailing wage rate for each classification of labor including appropriate fringe benefits in accordance with the statutes of the State of New Jersey. The higher of either State or Federal wages and fringe benefits for each classification will be obtained from the wage rate determinations applicable at the time of contract signing.

The successful bidder will be required to comply with all provisions of Executive Order 11246 of September 24, 1965, and all of the rules, regulations and relevant orders of the Secretary of Labor.

Cumberland County is exempt from the payment of sales tax and use taxes in accordance with N.J.S.A. 54:32B-8 and N.J.S.A. 54:32B-9.

In accordance with U.S. 2 CFR 200.326 (a) Each bidder shall be required to submit a Bid Security in the amount of 5% of their bid with their bid. Each bidder shall also be required to submit a Consent of Surety with their bid.

The successful bidder will be required to furnish a Performance Bond and a Payment Bond acceptable to Cumberland County, in the amount of one hundred percent (100%) of the contract, in conformity with the requirements of the Contract Documents and U.S. 2 CFR 200.326 (b)(c).

The successful bidder will be required, upon final payment, to furnish a General Maintenance Bond acceptable to Cumberland County, in conformity with the requirements of the Contract Documents.

No bid may be withdrawn for a period of sixty (60) days after the date set for the opening thereof. The right is reserved to reject any or all bids or to waive informality in the bidding if it is in the interest of Cumberland County to do so.
