### III. Youth Provider Reports- PY July 1, 2024 – June 30, 2025

o Salem

RanchHope – Out of School Youth

Jonathan Cummings – some youths have received their ASE Certifications; few are in the process of earing their GED; 1 has passed the GED; 10 students in the program; expecting to have 5 in work experience programs

Cumberland

PathStone - Out of School Youth

Christine Colon- 26 out of 40 enrollments and have started college readiness as well as academic skills; 12 have completed their hours; 7 have increased skills gains; 6 obtained high school diplomas; 10 have started GED; 5 have started paperwork on Work Experience; 3 have physically started Work Experience; 1 has completed; 2 have entered employment

#### LSI - Out of School Youth

Dani Williams- 1 enrolled; waiting for paperwork for 4 others

Nordica Powell – Has been reaching out to agencies in both Cape May and Cumberland Counties. The enrollment process has been challenging. Hopeful that they will see improvement as information spreads through word of mouth and social media. Program is online making it easier for participants with transportation challenges to work towards their GED.

# Cumberland Employment & Training – In School Youth

April Gomez – Reported out on behalf of Jaime Gomez who was absent due to a schedule conflict. Enrolled 20; Level of Service 20; 20 completed Workplace Readiness; 14 Career Exploration; 20 Financial Literacy. Currently working to set up work experience sites for all 20 youth - starting in February.

## • In School Youth

Emma Curry – introduced the team from Jersey Cape.

Brittney Guthri- oversees the In School Youth; 26 students in Pre-ETS; at least 1 from each high school

#### • Out of School Youth

Kelly Dean- 7 enrolled; completed intakes that brought numbers up to 9; working with 2 more to get them enrolled. She shared a success story about a student who came from Poland with his family to the United States. Jersey Cape started working with him in July and he finished his GED by November. Expecting more students to test by February.

Jersey Cape is looking to build an ESL class into their program for individuals that need counseling and teaching. Also, looking into starting a podcast centered around education and obtaining GEDs.

Joe Sittineri – mentioned some of the challenges of locating the out of school youth for programs. Discussion opened up within the group regarding challenges with paperwork and working with schools to find those individuals dropping out.
